Request for Expression of Interest (REoI)
For
“Engineering Consultancy Services for Payra-Gopalganj-Aminbazar 400kV Double Circuit Transmission Line (2nd Phase)”

1. BCPCL has signed contract with EPC Contractor for Payra-Gopalganj-Aminbazar 400kV Double Circuit Transmission Line (2nd phase) Project on Turnkey Basis. Now, BCPCL intends to appoint an international consultancy firm to Review of EPC Contractor’s Engineering Drawings, Documents and provide Field Engineering and Site Supervision services during the Construction Period. The cost of the said services will be borne by BCPCL.
2. The objectives of the consulting services (“the Services”) mainly include the following:
 - i) Design Review (Stage I): Review & approval of EPC Contractor’s Engineering and Design document;
 - ii) Construction Phase (Stage II): Field Engineering / Site Supervision and witness of Testing and Commissioning;
3. The Consultancy service for all the activities are expected to commence from the date of signing of Contract. Duration of the Contract will be 36 months.
4. BCPCL now invites eligible consultancy firms (“Consultants”) to indicate their interest in providing the Services. The Consultancy Firm should have at least relevant experience in the below mentioned points:
 - i. The firm shall have at least one (1) successfully completed project experience of extra high voltage transmission line and substation having capacity 345 kV or above in the field of design review, construction supervision and witnessing of testing & commissioning works.
 - ii. The firm shall have overseas experience of at least one (1) successfully completed project of extra high voltage transmission line having capacity 345 kV or above in the field of design review, construction supervision and witnessing of testing & commissioning works.
 - iii. The firm shall have at least one (1) successfully completed river crossing (span length should be 600m or more including two or more tower foundation within the river bed) project experience of high voltage transmission line having capacity 220 kV or above in the field of design review, construction supervision and witnessing of testing & commissioning works.
 - iv. The firm must have origin from eligible source of country (All countries except Israel).
 - v. The firm shall have experience in design / design review and construction supervision of transmission line utilizing ACCC conductor.
 - vi. The firm shall have a minimum liquid asset amounting USD 500,000 (five hundred thousand) only or equivalent in other currencies.
 - vii. The firm shall have a minimum average annual turnover amounting USD 2,000,000 (two million) only or equivalent in other currencies in last 3 years.

6. A firm will be selected in accordance with the Quality Cost Based Selection (QCBS) method.
