





The project consists of two (2) units of Ultra Super Critical Coal-Fired Power Plant each with a gross capacity of 660MW. The 1 st Phase has commenced commercial operation from December 2020. Now BCPCL invites qualified Gypsum Receiver to buy and to take delivery of Gypsum generated from Payra 1320MW Thermal Power Plant. The Contract Period will be for five (5) years.

Limited – Taka Revenue Account in the form of an international bank draft encashable at any scheduled bank in Bangladesh or in the form of local bank draft/pay order".
