The project consists of two (2) units of Ultra Super Critical Coal-Fired Power Plant each with a gross capacity of 660MW. The 1 <sup>st</sup> Phase has commenced commercial operation from December 2020. Now BCPCL (Employer) invites qualified Gypsum Receiver (Buyer) to buy and to take delivery of Gypsum generated from Payra 1320MW Thermal Power Plant from the specified spot described in the tender documents. The Contract Period will be for two (2) years.
