#### Terms and Conditions for

### "West Side Living Area Network Expansion Project" & Network Maintenance at Payra 1320MW TPP site

- 1. Terms and Conditions contained herein shall be binding upon both the Procuring Entity and the Supplier for the purpose of administration and management of this Contract.
- 2. Implementation and interpretation of these Terms and Conditions shall, in general, be under the purview of Procurement Procedures of BCPCL.
- 3. The Supplier shall have to complete the delivery in all respects within **30 days** of contract agreement signed in between the parties in conformity with the Terms and Conditions.
- 4. The Supplier shall submit necessary Installation Plan and relevant single line diagrams prior to the commencement of physical service to BCPCL and take necessary approval from the competent authority.
- 5. The Supplier shall be entitled to an extension of the Delivery Schedule if the Procuring Entity delays in receiving the goods and related services or if Force Majeure situation occurs or for any other reasons acceptable to the Procuring Entity on justifiable grounds duly recorded.
- 6. All delivery under the Contract shall at all times be open to examination, inspection, measurements, testing, commissioning, and supervision of the Procuring Entity or his/her authorized representative.
- 7. The Procuring Entity shall check and verify the delivery made by the Supplier in conformity with the Technical Specifications and notify the Supplier of any Defects found.
- 8. If the Goods are found to be defective or otherwise not in accordance with the specifications, the Procuring Entity may reject the supplies by giving due notice to the Supplier, with reasons.
- 9. The Supplier shall be entirely responsible for payment of all taxes, duties, fees, and such other levies under the Applicable Law.
- 9. The Supplier's rates or prices shall be inclusive of profit and overhead and, all kinds of taxes, duties, fees, levies, and other charges to be paid under the Applicable Law.
- 10. Any form of testing and commissioning during the process needs to be performed in front of the designated officials of BCPCL.
- 11. The total Contract Price is BDT [insert figure] [in words].
- 12. Notwithstanding any other practice, the payment shall be made based on the actual delivery of goods on the basis of the quantity of each item of Goods in accordance with the BoQ, Specifications and successful completion of installation, testing & commissioning and duly accepted by BCPCL.
- 13. The Procuring Entity shall retain from the contract value due to the Supplier at the rate of 5 (Five) **Percent** as Retention Money until completion of the Warranty period. It will be retained from the final payment made to the awarded supplier.
- 14. The Supplier shall repair/replace the goods covered by the Warranty period within 15 days of being notified by the Procuring Entity of the occurrences of any defect.
- 15. The minimum Warranty Period of the Supplies shall be 12 months starting from the date of successful completion of Supply, Installation, Testing & Commissioning by the Supplier and acceptance by the BCPCL.
- 16. After the Warranty Period has passed and the notified defects are corrected and, the Procuring Entity shall release 5 (Five) Percent Retention Maney to the supplier.

- 17. The Warranty Period may be extended for as long as the Defects notified by the Procuring Entity remain to be corrected.
- 18. If the Supplier has not corrected a Defect within the time specified in the Procuring Entity's notice, the Procuring Entity shall assess the cost of having the Defects corrected by it, and the Supplier shall remain liable to pay the expenditures incurred on account of correction of such Defects.
- 19. The Supplier shall remain liable to fulfil the obligations under the Applicable Law.
- 20. No works under Extra Work Orders shall be permissible and, works under Variation Orders (except in case of Lump-sum basis) shall under no circumstances exceed twenty (20) percent of the Contract Price subject to threshold specified in the Procurement Procedures and Delegation of Financial Power-2019 of Bangladesh China Power Company (Pvt.) Limited.
- 21. The Procuring Entity contracting shall amend the Contract incorporating required approved changes subsequently introduced to the original Conditions of Contract in line with Rules, where necessary.
- 22. The Firm shall apply by notice to the Procuring Entity for issuing a Completion Certificate of the Works, and the Procuring Entity shall do so upon deciding that the work is completed.
- 23. The Procuring Entity shall, within 07 (Seven) working days after receiving the Firm's application: i. issue the Completion Certificate to the Firm stating that the Works were completed in accordance with the Contract, or
  - ii. reject the application, giving reasons and specifying the works required to be done/redone by the Firm to enable issuance of the Completion Certificate.
- 24. The Supplier shall keep the Procurement Entity harmless and indemnify from any claim, loss of property or life to himself/herself, his/her workmen or staff, any staff of the Procurement Entity or any third party while delivering the Goods and related services.
- 25. Any claim arising out of delivery of Goods and related services shall be settled by the Supplier at his/her own cost and responsibility.
- 26. Damage to the Goods during the Warranty Period shall be remedied by the Supplier at the Supplier's own cost, if the damage arises from the supply and installation by the Supplier.
- 27. No modification to Scope of Supply and no Variations to the quantities ordered shall be permissible under any circumstances.
- 28. The Procuring Entity contracting shall amend the Contract incorporating required approved changes subsequently introduced to the original Terms and Conditions in line with the applicable law, where necessary.
- 29. The Procuring Entity may, by written Notice sent to the Supplier, terminate the Contract in whole or in part at any time, if the Supplier:
  - a. fails to deliver Goods and related services as per Delivery Schedule and Specifications.
  - in the judgement of the Procuring Entity, has engaged in any corrupt, fraudulent, collusive or coercive practices in competing for or in delivery of goods and related services.
  - c. fails to perform any other obligation(s) under the Contract.
- 30. The Procuring Entity and the Supplier shall use their best efforts to settle amicably all possible disputes arising out of or in connection with this Contract or its interpretation.
- 31. The Supplier shall be subject to, and aware of provision on corruption, fraudulence, collusion and coercion with the applicable law.
