### INFORMATION FOR TENDERER

11.	Eligibility of Tenderer	The Tenderer must have a minimum of five (5) years of overall experience as a manpower service provider.
		The Tenderer must have specific experience in providing manpower services of a similar nature, completed or partially completed*, within the last three (3) years, with a minimum cumulative contract value of BDT 10,000,000.00 (one crore) across a maximum of two (2) contracts. To meet this qualification, the Tenderer must provide experience certificates issued by Government, Semi-Government, Autonomous Bodies, Government Companies, Power Plants, Multinational Corporations, or Local Conglomerates. <i>*Providing manpower services for a minimum period of one (1) year under a contract will qualify as partially completed.</i>
		The Tenderer shall have minimum amount of liquid asset or working capital or credit facility of Tk. 4,000,000.00 (forty lac) from any scheduled Bank of Bangladesh.
		The Tenderer must possess a valid trade license, TIN, and VAT registration issued by the relevant authorities in Bangladesh. Additionally, the Tenderer must provide documentary evidence of specific experience, such as work orders, purchase orders, or contract agreements.

Brief Description	The Tenderer shall deploy 50 personnel, including supervisors, laborers, and machine operators, along with providing necessary PPE for the workforce and tools required for maintenance, as specified in Section 6: Activity Schedule and Section 7: Performance Specifications of the tender document.
