- 1. Bangladesh-China Power Company (Pvt.) Limited (BCPCL), a Joint Venture Company (JVC) of NWPGCL of Bangladesh and CMC of China, is implementing coal based Payra 1320 MW Thermal Power Plant Project (Phase I) at Dhankhali, Patuakhali, Bangladesh.
- 2. The expected COD of the 1<sup>st</sup> Unit of this plant is December 2019. The current physical progress is around 81%.
- 3. The project consists of two (2) units of Ultra Super Critical Coal Fired Power Plants each with a gross capacity of 660MW (each).
- 4. Now Bangladesh-China Power Company (Pvt.) Limited (Employer) invites qualified Ash Receiver (Buyer) to buy and to take delivery of Fly Ash and Crushed Bottom Ash (collectively called Dry Ash) generated from Payra 1320MW Thermal Power Plant (Phase I) from the specified spot described in the tender document. The Contract Period will be for five (5) years with option to extend for another five (5) years.
- 5. Only eligible Tenderers with the following key qualifications, summarized from the Tender Document, are invited to participate. Tenderers are requested to refer to Criterion 11, 12, 21 and 23 of Section 1 Instruction to Tenderers of the Tender Document for a full range of criteria prior to submitting their Tenders. In case of any discrepancies between this Invitation for Tenders and the Tender Document, the Tender Document shall prevail.
  - a) Minimum number of years of overall experience in the field of Ash Handling and Processing System and related services shall be: ten (10) years as on Tender Closing Date.
  - b) Minimum specific experience in installation and operation of Pneumatic Ash Handling System shall be: three (3) years as on Tender Closing Date.
  - c) Minimum capacity for end utilization shall be: 1,000 tons per day.



- d) The minimum value of Dry Ash purchased in the last three years under a single contract shall be at least 25% of the total price of Fly Ash and Bottom Ash mentioned in Form G-2. (Column 8 of Item No. 1 and Item No. 2 in Form G-2.)
- e) The minimum amount of liquid asset or working capital or credit facility shall be at least 25% of total of column 8 of Item No. 1 and Item No. 2 in Form G-2.
